semester, 4.3 percent of students (720) have cross enrolled in courses at more than one university, to date.

As of Tuesday, UAA headcount was 1.7 percent (159) higher and SCH4.7 percent (4,078) higher than last year. Matanuska -Susitna College accounted for 30 percent (1,224) and Kenai Peninsula College for 28 percent (1,144) of overall UAA SCH growth to -date. Course registration trends reported for Anchorage Campus, UAA and the UA System are impacted by a business practice change removing Professional and Continuing Education (PACE) 500 level courses from the Banner system starting in 2024. Fall 2023 course registration data includes PACE course activity, accounting for 109 students and 338 SCH at this time last year.

UAFheadcount increased 3.1 percent (191), with students registering in 4.1 percent (2,330) more SCHyear-over-year. At UAF, the College of Natural Science and Mathematics accounted for 55 percent (1,291) and the College of Business and Security Management 23 percent (532) of overall UAF SCH growth this Fall.

At UAS, student headcount increased 3.9 percent (64), and student credit hour registration increased 0.7 percent (91) from Fall 2023. Gains of nearly 324 SCH at the School of Arts & Sciences more than balanced out declines observed at other campuses compared to Fall 2023.

Total fall semester net tuition and fee s billed to registered students, to date, is 6.5 percent (\$3.8M) higher this year than last . UAA billed net tuition and fee s increased 5.7 percent (\$1.8M), UAF increased 8.5 percent

3.5 percent (29 applications) over last year. Applications initiated by prospective first-time freshmen accounted for 61. 0 percent of all initiated applications to -date, with growth of 8.1 percent (315 applications) at UAA, 98.6 percent (1,798 applications) at UAF, and 10.9 percent (47 applications) at UAS, year -over-year.
